IMPORTANT REMINDERS: NO GRACE PERIOD FOR GAMES, except for a 15 minute grace period for the first games played during the weekdays.

Home team responsibilities include padding the goal posts. Game cannot be played unless goal posts are padded. Home team is also responsible for ensuring that field has restraining ropes or fence. Lack of restraining ropes or fence will cost your club \$125.00. Refer to 2017 Football Rules. Remember to have your ID check with the Field Supervisor early. It is the responsibility of the team coaches to give the line-up sheets to the Field Supervisor prior to the game. In the absence of a Field Supervisor, coaches must email or fax line-up sheets to the PGCBGC office at scorekeeper@pgparks.com or 301-446-6801. Be sure to have officials to sign your sheet. Your scores will be recorded from these sheets.

For field closing due to inclement weather, please call 301-927-0822 to check on cancellations.

Accommodations for individuals with disabilities are available upon request. Please contact the facility two weeks in advance of the program start date. Additionally, the Department of Parks and Recreation requests a 72-hour advance notice for the provision of language interpreters.
